

## Minutes of the Annual Public Meeting of the Board of Directors of the Florida Public Archaeology Network

Video Conference May 8, 2020

The Board of Directors of the Florida Public Archaeology Network (FPAN), University of West Florida, held its Annual Board meeting on May 8, 2020, from 9:30 am until Noon Eastern Time via Zoom video conference. The meeting was conducted virtually because of the coronavirus pandemic and the social distancing and quarantine orders.

**Agenda Item I.** The meeting was called to order by Chair Dr. Judy Bense at 9:34 am Eastern. Dr. Bense recognized that 31 people were online and thanked them for attending.

**Agenda Item II.** Board Members present were Dr. Judy Bense (chair), Dr. Greg Cook (vicechair), Ms. Marion Almy, Ms. Adrienne Burke, Dr. Ramie Gougeon, Dr. Jeff Mitchem, Dr. Matthew Reeves, and Dr. John Worth. Mr. Chris Davenport, Dr. Mary Glowacki, and Dr. Jason Wenzel were absent. Also present were Dr. William Lees, executive officer and secretary of the board and Dr. Elizabeth Benchley, staff advisor to the board.

**Agenda Items III and IV**. Dr. Bense called for any additions or changes to the draft agenda. A motion was made to accept the agenda as presented (Motion 1, M/S/Approved).

Dr. Bense called for additions or changes to the draft minutes from the November 18, 2019, meeting of the board. A motion was made to accept the November 18, 2019, minutes as presented (Motion 2, M/S/Approved).

**Agenda Item V.** Dr. William Lees gave the Executive Director's Report. Bill said he is happy to report that everyone is safe and well. He noted that Chris Davenport was absent because he is helping to deliver personal protection equipment throughout the state of Florida. FPAN was set for a busy Archaeology Month but all that changed with the coronavirus pandemic. On March 9, 2020, FPAN staff decided not to schedule any future programming but continue with already scheduled programs for the month. On March 10 Bill attended the Archaeology Bootcamp in West Palm Beach and while there, a global pandemic was declared and Archaeology Month programming was canceled. As of today, FPAN staff is working remotely until further notice. All travel has been canceled and no group meetings can be held.

Dr. Lees noted that due to the COVID-19 closures, two months have been lost on the HMS grant site monitoring. FPAN continues to write permit applications. He acknowledged Brandon Ackerman for helping to get those applications approved. There are permits in the queue so when the state is reopened, staff will be ready to get back to monitoring. He

anticipates staff will have to continue virtual programming for a while and when they can get in the field will have to consider everyone's safety.

Dr. Lees gave a shout-out to Sarah Miller for introducing Zoom to FPAN last fall before Zoom became such a part of our lives during the pandemic.

The Annual Work Plan and Strategic Goals and Objectives were successfully developed remotely but he admitted it is not the same as meeting in person.

Dr. Lees shared photos of the steering committee that started FPAN 15 years ago and of the white board notes of the MOA that includes public outreach and assistance to DHR. He noted that he and all the staff are ready to get back to the office and continue working with DHR, Dr. Tim Parsons and Dr. Mary Glowacki.

Dr. Bense noted that the pandemic has interfered with everything. Crafting the annual work plan took time and Tim and Mary were very busy. She assured everyone that we would reach common ground on the work plan.

Dr. Lees asked Dr. Reeves what they are doing in Virginia regarding the social distancing. Matt reported that the new Montpelier Foundation President has decided to reopen the trails but not the museums. Archaeology is seeking funds and creating visual paperwork for public programs. They are waiting for protocols and to see what Virginia state universities are doing. They are also waiting to see what the travel restrictions will allow since they have a lot of visitors who travel in from out of state.

**Agenda Item VI.** Dr. Lees provided a status update on the Annual Work Plan with DHR. Last year, Dr. Parsons sent ideas to FPAN for the work plan. Bill and Tim planned to get together for more discussion but could never meet face-to-face. Bill worked on the plan and sent the draft to Tim and Mary Glowacki. With the state closures caused by the pandemic, Tim and Mary have not had time to get with Bill for further discussion. Tim sent comments May 7, 2020.

Dr. Bense thanked Dr. Parsons for his comments which were shared with the Board May 7. Dr. Parsons said he realizes there is a lot of information to unpack and there is a need to identify strategies for going forward. Future discussions will figure out the best direction forward; the MOA can be amended if needed. He is open to ideas and will help develop a work plan that works. FPAN's net has grown over 15 years; staff is doing more than what was done in 2005 and may need to look at what the staff is doing.

Dr. Parsons included the BAR update as Dr. Glowacki did not attend. In March, the State of Florida started closing museums and offices. Almost all staff is working remotely. The state closure expires May 17 and May 18 state buildings will open up. They are waiting to determine if museums will open and if there is a need to extend remote working. He stated he would be surprised if any travel can be conducted in the rest of 2020. He said they have done everything they can to keep programs running and is proud of the work they have done.

Regarding the work plan and/or MOA with DHR, Dr. Bense said to be thinking about forming a task force and having a workshop if staff can travel or have as Zoom meetings. She thanked Tim for trouble shooting and keeping things running.

**Agenda Item VII.** Sarah Miller, Patty Meyers-Gidusko, and Kassie Kemp provided an update on the HMS Grant. Sarah reported that the funds and deliverables are on track. About 136 sites had been monitored before the pandemic hit. Patty said she is working closely with Bill Stanton and they determined 50 permits are needed for state parks. FPAN currently has 6 permits with another 10 in various states of progress. Brandon Ackerman has been a great help. Kassie gave an update on Arches, the program used to track scout reports. There have been some major updates to Arches in the last few months such as a map filter, image options, map overlays, and the ability to show regions. They are working on making sure the database is updated and are looking at land management accounts. Five hundred sites need to be monitored by June 2021. Dr. Bense thanked them for their hard work.

**Agenda Item VIII.** Dr. Scott-Ireton gave an overview of the Strategic Goals and Objectives 2020-2025. She noted this was very much a group staff project and it is a living document that can be updated and revised as needed. It is intended to be an overarching guide with four main goals: (1) climate change, (2) social equity and inclusion, (3) site stewardship, and (4) viability.

**Agenda Item IX.** Each Regional Director and the DARC Director gave field reports. Each person provided a quick review of the programs they've held over the past year and the programs they've been able to hold via social media and video conferencing such as Zoom since the coronavirus pandemic was declared. Many photos were shared of the staff, volunteers and organizations involved.

They are updating their ethics statement and plan to raise the annual dues in 2021. The FAS Conference was canceled in May because of the coronavirus pandemic and the ban on travel and social distancing. FAS has renegotiated the contract with the Naples Ritz. FAS will have to determine in August or September if they can host the conference on October 2-4, 2020, depending on the pandemic status at that time.

**Agenda Item XI.** Dr. Bense called for any old business to be discussed. No old business was presented.

**Agenda Item XII.** Dr. Bense called for any new business to be discussed. The FPAN Board was asked if they wanted to include a face-to-face meeting at the FAS Conference if it is held in October. Dr. Lees noted that perhaps FPAN can use some of the leftover 2019-2020 budget to cover two face-to-face meetings in 2020-2021. The board was in general agreement to meet face-to-face but will have to wait until closer to the October conference date to see where things stand with the budget and virus restrictions.

**Agenda Item XIII.** Dr. Bense asked if there were any public comments; there were none.

**Agenda Item XIV.** Meeting was adjourned.
